

## Higher Education Emergency Relief Funds (HEERF) III American Rescue Plan Act (ARP) of 2021: Student Portion

HEERF III ARP Total: \$204,202

### **Purpose:**

To provide emergency financial aid grants to students, “which may be used for any component of the student’s cost of attendance or for emergency costs that arise due to coronavirus, such as tuition, food, housing, health care (including mental health care) or child care.”<sup>1</sup>

### **Disbursement 1 of HEERF III ARP:**

Total disbursed: \$102,101

### **Elim Bible Institute and College HEERF III ARP Eligibility Criteria:**

- Enrolled as a student for the 2021-2022 academic year.
- Enrolled either in an **undergraduate program** or as an **undeclared student**
  - Audit students not eligible
- Be a U.S. Citizen, permanent residents, international students, refugees, asylum seekers, DACA recipients, or DREAMER
- Exceptional financial need prioritized based on reported 2021-2022 Estimated Family Contribution (EFC)
  - Any student who did not submit a 2021-2022 FAFSA will receive the lowest bracket of HEERF III ARP per their enrollment and residency category.
  - Exception: All international students are categorized as \$0 EFC for eligibility purposes.
